The said KOU HER did on or about May 10, 2013, in the County and State aforesaid, under circumstances manifesting extreme indifference to the value of human life, purposely engage in conduct that created a substantial danger of death or serious physical injury to another person or persons, to wit: Tou Jee Xiong, the same being a CLASS D FELONY, against the peace and dignity of the State of Arkansas.





Pursuant to Rule 7.1 of the Arkansas Rules of Criminal Procedure, the undersigned Affiant being first duly sworn and upon oath, deposes and says that he/she has reason to believe that the above named person has committed the offense/s of MURDER IN THE FIRST DEGREE, AGGRAVATED RESIDENTIAL BURGLARY, ATTEMPTED KIDNAPPING, BATTERY IN THE FIRST DEGREE AND AGGRAVATED ASSAULT in violation of A.C.A. § 5-10-102, 5-39-201, 5-11-102, 5-13-201 AND 5-13-204 in Johnson County, Arkansas on or about MAY 10, 2013, committed as follows: to wit:

**FACTS CONSTITUTING REASONABLE CAUSE**

On Friday, May 10, 2013, at approximately 3:45 a.m., Johnson County Deputies responded to a call at 567 County Road 2243 near Hartman, Arkansas. The nature of the call was that a male suspect had made entry to the residence through a window, and persons inside the residence were injured. The suspect was later identified as KOU HER. KOU HER was subdued at the residence by Alex Xiong and Tou Jee Xiong who detained him until law enforcement arrived.

After further investigation, it was found that the suspect, KOU HER, had stabbed a 6 year old female (Victim "A") in the side of the head, behind her ear. The suspect, KOU HER, had also tried to suffocate a 14 year old female (Victim "B") with a rag soaked in what is believed to be gasoline. Victim "B" was sleeping in the bed with the 6 year old female (Victim "A"). Alex Xiong, 21 year old brother of Victim "B", entered the bedroom after he heard the commotion with the victims and the suspect, KOU HER, and was stabbed by the suspect, KOU HER. Tou Jee Xiong, who also resided in the home, was also injured by the suspect, KOU HER. The suspect, KOU HER, was armed with a pair of scissors and a large kitchen knife.

Victim "A" was taken to the hospital because of the stab wound to her head inflicted by the suspect, KOU HER. She later died of those injuries.

Alex Xiong was taken to the hospital to get treatment for the serious physical injuries he received due to the stab wound to his upper body inflicted by the suspect, KOU HER.

The vehicle that KOU HER was driving was found near the end of the driveway of the home where the offenses took place approximately 1/10th of a mile from the house. The vehicle was found to have evidence of a planned kidnapping which included among other things, tape, black trash bags, braided string, gloves, paper towels, scissors and a camera.
